




### Scenario: Pickup Trucks







#### ~384 new mines needed for EV & energy storage batteries by 2035 (Benchmark Mineral Intelligence)










## Awareness is low

**73%** of people have seen *"just some"* or *"nothing"* about states adopting car bans.


#### Poll:




## Large majorities oppose car bans

Do you support or oppose government policies to ban new gas, diesel and hybrid vehicles, effectively mandating electric vehicles?






Poll:
